

# PRIVACY POLICY

This Policy is provided to inform you of the ways JCM collects, uses, stores, transfers and discloses your personal information. By providing your information, you agree to your personal information being processed in accordance with this Privacy Policy, as amended from time to time.

## Collection & Use of Identifiable Information

We may ask you to provide us with identifiable personal information while using our websites and any apps. This information is collected and used only for the purposes indicated where and when the information is requested or collected. If we wish to use your personal information for a new or different purpose, we will offer you the means to consent to this purpose at the point where the use of your personal information is requested. Except as requested by you, or as indicated on the webpage or any app where your information is requested, we do not disclose your identifiable personal information to other organizations.

## Privacy

JCM is committed to safeguarding your personal information. We keep any personal information in the strictest confidence. JCM strives to comply with applicable laws, regulations, standards, and guidelines established by governmental agencies and accepted accrediting organizations at all times. These include the European Union's General Data Protection Regulation, where applicable.

## Use of "cookies"

As you browse JCM's website and any apps, "cookies" may be placed on your computer so that we can understand your interests and enhance your experience. Cookies do not collect information about you. Rather, a cookie may contain limited information, such as the type of browser you are using, your general location, your device's IP address, the date and time of your visit, your web domain type, and your activity on our website. None of this information in any form or combination will be traced back to you by JCM.

JCM's website also may use cookies as a security measure to help provide you with a secure online experience. Most browsers allow you to delete, block, or otherwise restrict cookies on your computer. However, this may affect your ability to use JCM's website and any apps.

JCM may share cookie information with our advertising and marketing partners (including, but not limited to, those employed by JCM, its volunteers or any officers) so that we can present you with relevant advertising on other sites or with marketing information based on your previous interaction with JCM's website and any apps.

As you browse the JCM website and any apps, your IP address and/or http requests (URLs) may be used to gather navigation and usage patterns across various browsers and devices. The purpose of such tracking is to help JCM understand how its website/app(s) are being accessed and to enhance usability. These IP addresses and http requests (URLs) are not used to trace back and re-identify specific users.

## Content Ownership

JCM is the sole owner of content on our websites and any apps, and may change it from time to time without notice. The entire contents and design of JCM's websites and any apps are protected under U.S. and international copyright laws. You may look at our content online, download information to your computer to read later, or print copies of pages for yourself, your family, or your friends. However, you must not remove any copyright notices from our content. We reserve all rights, which means that you must not sell our content, rewrite or modify it, redistribute it, use it on your own website, or use it for any commercial or non-personal purpose without JCM's prior written permission.

## **Social Media**

JCM appreciates the importance of the visitor experience. In certain cases, JCM may give you the opportunity to post information on JCM's website (such as prayer requests) or other social media sites in which JCM participates (such as Facebook, Twitter, Instagram and YouTube). We encourage you to "like" any post and to share with your friends using "share" links. Discussions, questions, and commentary are welcome, and JCM asks that posts be respectful. Through JCM's participation on any social media site, JCM agrees to observe the site's posting guidelines and terms of use, as well as our own.

JCM shall not be held responsible for content submitted by other site users on any platform. JCM also reserves the right to remove any posts, graphics, comments, videos, photos, or any other content that:

- Is libelous, defamatory, or disparaging
- Violates another party's copyright, trademark, or other intellectual property rights
- Affects the privacy rights of any of our contributors, including the person posting the content, or of any JCM employee
- Condone or promotes illegal activity
- Is inaccurate, misleading, fraudulent, or deceptive
- Uses harsh, obscene, hateful, or threatening language
- Is spam, or is intended to cause technical disruptions to JCM's website or social media site
- Offers unauthorized advice or tips
- Markets commercial products or solicits monetary contributions to any organization
- Is off-topic or excessive
- Violates any applicable law

JCM is not obligated to respond to any post or request for information or advice made on a social media site.

## **Online Forms**

At times, JCM may ask you for personal information while you are visiting our website. We ask for this information only to deliver materials that you have requested, register you for an event, to respond to a question you have asked, or to provide you with a product or service.

When you enter data into an online form on our website, the personal information you type is protected and securely transmitted to us through a method such as a Secure Sockets Layer (SSL). SSL is the standard method that websites use to protect visitors' information by coding or "encrypting" everything from credit card transactions to enrollment data.
